### PRODUCT INFORMATION

**COMPLETE** is a well balanced liquid plant food containing the **primary** and **secondary** plant nutrients. The **secondary** plant nutrients are chelated with **EDTA** to provide fast break and ease of mobility into the plant system.

**COMPLETE** promotes healthy seed and root development as well as a strong cell structure when used as a supplement to a soil fertilizer program. Micronutrients are needed for healthy seed development, root structure and cell structure, especially in soils where the nutrients have been depleted in sufficient quantities to cause reduced yields or stunted plants. **COMPLETE** insures against these nutrients deficiencies providing the essential nutrients to stimulate early root development and speed up plant growth

**COMPLETE** liquid nutrients contain ENHANCE\* (THA) Technical Humic Acids to help promote rapid absorption through the leaf tissue and root system of the plant.

**COMPLETE** nutrients are available for plant food and non-phytotoxic when used as directed.

### SUGGESTED USES AND APPLICATION RATES

#### SOIL APPLICATION RATES

**Drip Systems and Drip Tape** - 1-8 quarts (1-8 liters) per acre, application depending on the crop and its growth stage. If a pre plant fertilizer is used, a total of 2-5 gallons (8-19 liters) **COMPLETE** is recommended. If a pre plant fertilizer is not used a total of 5-10 gallons (19-38 liters) per acre throughout the growing season is recommended.

**Sprinkler systems — Flood Irrigation** — These systems are not as effective for fertilizer application as drip systems. For best results, follow drip recommendations. A pre plant or side dress application often is required for this type of irrigation system.

**Foliar Application — Air or Ground Rig Tree Crops** — 1-2 quarts per acre Vegetable Crops — 1-4 pints per acre Field Crops — 1-4 pints per acre

**Dilution Rates** — Use a minimum of 10 gallons (38 liters) of water per acre.
