GENERAL INFORMATION

ENHANCE ORGANICS is a complex formulation allowing quick movement of nutrients in the soil and promoting **RAPID ABSORPTION** of nutrients through the root system.

ENHANCE ORGANICS is designed to promote healthy seed and root development as well as a strong and healthy cell structure by providing a fast method of increasing **NUTRIENT** levels in the plant during critical growing periods.

GENERAL USE

ENHANCE ORGANIC can correct nutrient deficiencies under many soil conditions ranging from high organic matter (clay) to very low organic matter and from strong acid soils (pH 3) to high alkaline soils (pH 8.5) containing calcium carbonate free lime. **ENHANCE ORGANICS** can be used on most crops.

ENHANCE ORGANICS is unique because it can be incorporated in all types of fertilizer applications. The **ENHANCE ORGANIC** product can be banded, side dressed, applied through drip systems, sprinklers and foliar applications.

APPLICATION RATES SOIL APPLICATION RATES

DRIP SYSTEMS and **DRIP TAPE** -1-4 quarts (1-4 liters) per acre, application depending on the crop and its growth stage. If a pre plant fertilizer is used, a total of 2-10 gallons (8-19 liters) **ENHANCE ORGANIC** is recommended. If a pre plant fertilizer is not used a total of 5-20 gallons (19-38 liters) per acre throughout the growing season is recommended.

If soil and petiole tests show a deficiency in micronutrients **WESTERN NUTRIENTS START UP** line should be added to **ENHANCE ORGANIC**. Start Up chelated micronutrients should be added at the rate of ½ pint per gallon (¼ liter per 4 littlers) of **ENHANCE ORGANIC**. If a number of micronutrients are deflicient do not exceed 1 pint (½ liter) Start Up products per gallon (4 liters) of **ENHANCE ORGANIC**. For best results to obtain additional micronutrient boost use **WESTERN NUTRIENTS CORPORATION NUTRAPLEX** or **MICRO PLUS FOLIAR LINES** of products.

SPRINKLER SYSTEMS - FLOOD IRRIGATION -

These systems are not as effective for fertilizer application as drip system. For best results follow drip recommendations. A preplant or side dress application often is required for this type of irrigation system.
