GENERAL INFORMATION

WN GOLD LABEL™ BRAND NITROGEN BOOSTER is a new formulated fertilizer which allows **NITROGEN** to move freely in the soil. The fertilizer is protected by natural carriers developed by Western Nutrients Corporation.

GOLD LABEL™ BRAND NITROGEN BOOSTER is a complex formulation allowing quick movement of nutrients in the soil and promoting **RAPID ABSORPTION** of nutrients through the root system.

WN GOLD LABEL™ BRAND NITROGEN BOOSTER is designed to promote healthy seed and root development as well as a strong and healthy cell structure by providing a fast method of increasing **NITROGEN** levels in the plant during critical growing periods.

GENERAL USE

WN GOLD LABEL™ BRAND NITROGEN BOOSTER can correct nutrient deficiencies under many soil conditions ranging from high organic matter (clay) to very low organic matter and from strong acid soils (pH 3) to high alkaline soils (pH 8.5) containing calcium carbonate free lime. **GOLD LABEL™ BRAND NITROGEN BOOSTER** can be used on most crops.

GOLD LABEL™ BRAND NITROGEN BOOSTER is unique because it can be incorporated in all types of fertilizer applications. The **GOLD LABEL™ Brand** product can be banded, side dressed, applied through drip systems, sprinklers and foliar applications.

APPLICATION RATES

SOIL APPLICATION RATES

Drip Systems and Drip Tape — 1 - 4 quarts (1 - 4 liters) per acre, application depending on the crop and its growth stage. If a pre plant fertilizer is used, a total of 2 - 5 gallons (8 - 19 liters) **GOLD LABEL™ NITROGEN BOOSTER** is recommended. If a pre plant fertilizer is not used a total of 5 -10 gallons (19 - 38 liters) per acre throughout the growing season is recommended.

If soil and petiole tests show a deficiency in micro-nutrients, **WESTERN NUTRIENTS START-UP™** line should be added to **GOLD LABEL™ NITROGEN BOOSTER**. **START UP™** chelated micronutrients should be added at the rate of ½ pint per gallon (¼ liter per 4 liters) of **GOLD LABEL™ NITROGEN BOOSTER**. If a number of micronutrients are deficient do not exceed 1 pint (½ liter) **Start-Up™** products per gallon (4 liters) of **GOLD LABEL™ NITROGEN BOOSTER**. For best results to obtain additional micronutrient boost use **WESTERN NUTRIENTS' NUTRAPLEX®** or **MICRO PLUS™ FOLIAR LINES** of products.

Sprinkler Systems — Flood Irrigation — These systems are not as effective for fertilizer application as drip systems. For best results, follow drip recommendations. A pre plant or side dress application often is required for this type of irrigation system.

Foliar Application — Air or Ground Rig

Tree Crop	- 1 quart (1 liter) per acre
Vegetable Crops	- 1 pint (½ liter) per acre
Field Crops	- 1 pint (½ liter) per acre

DILUTION RATES — Use a minimum of 10 gallons (38 liters) of water per acre.
